**YAKIMA VALLEY MEMORIAL HOSPITAL CHARITABLE FOUNDATION**

Pursuant to the provisions of Revised Code of Washington 24.03.170 of the Washington Nonprofit Corporation Act, Yakima Valley Memorial Hospital Charitable Foundation, a Washington nonprofit corporation, hereby adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the corporation is Yakima Valley Memorial Hospital Charitable Foundation.

**SECOND:** Article I of the Articles of Incorporation were amended in accordance with the provisions of RCW 24.03.170 by the Board of Trustees to read as follows:

I.

NAME

The name of this corporation is the Memorial Foundation.

**THIRD:** The following Articles XII and XIII were added to the Articles of Incorporation in accordance with the provisions of RCW 24.03.170 by the Board of Trustees:

XII

LIMITATION OF TRUSTEE LIABILITY

A. A trustee shall have no liability to the Corporation for monetary damages for conduct as a trustee, except for acts or omissions that involve intentional misconduct by the trustee, or a knowing violation of law by a trustee, where the trustee votes or assents to a distribution which is unlawful or violates the requirements of these Articles, or for any transaction from which the trustee will personally receive a benefit in money, property, or services to which the trustee is not legally entitled. Nevertheless, the liability of a trustee shall be eliminated or limited to the full extent permitted by the Washington Nonprofit Corporation Act, as so amended, without any requirement of further action by the Corporation. Any repeal or

modification of this Article shall not adversely affect any right or protection of a trustee of the Corporation existing at the time of such repeal or modification for or with respect to an act or omission of such trustee occurring prior to such repeal or modification.

B. If the Washington Nonprofit Corporation Act or, by reference, if appropriate, the Washington Business Corporation Act, hereafter is amended to authorize the further elimination or limitation of the liability of directors, then the liability of a trustee of the corporation, in addition to the limitation on personal liability provided herein, shall be limited to the fullest extent permitted by the amended Washington Nonprofit Corporation Act or the amended Washington Business Corporation Act, as appropriate.

C. In the event that any of the provisions of this Article (including any provisions within a single sentence) is held by a court of competent jurisdiction to be invalid, void, or otherwise unenforceable, the remaining provisions are severable and shall remain enforceable to the fullest extent permitted by law.

### XIII

#### INDEMNIFICATION OF TRUSTEES AND OFFICERS

A. Each person who was, or is, threatened to be made a party to or is otherwise involved (including, without limitation, as a witness) in any actual or threatened action, suit, or proceeding, whether civil, criminal, administrative, or investigative, by reason of the fact that he or she is or was a trustee or officer of the corporation, or, being or having been such a trustee or officer, he or she is or was serving at the request of the corporation as a trustee, trustee, officer, employee, or agent of another corporation or of a partnership, joint venture, trust or other enterprise, including service with respect to employee benefit plans, whether the basis of such proceeding is alleged action in an official capacity as a trustee, trustee, officer, employee, or

agent or in any other capacity, shall be indemnified and held harmless by the corporation, to the fullest extent permitted by applicable law as then in effect, against all expense, liability, and loss (including, without limitation, attorneys' fees, judgments, fines, ERISA excise taxes or penalties, and amounts to be paid in settlement) actually and reasonably incurred or suffered by such person in connection therewith. Such indemnification shall continue as to a person who has ceased to be a trustee, trustee, officer, employee, or agent and shall inure to the benefit of his or her heirs, executors, and administrators; provided, however, except as provided in paragraph B herein below with respect to proceedings seeking solely to enforce rights to indemnification, the corporation shall indemnify any such person seeking indemnification in connection with the proceeding (or part thereof) initiated by such person only if such proceeding (or part thereof) was authorized by the Board of Trustees of the corporation. No indemnification shall be provided under this paragraph if the corporation is prohibited by the Washington Business Corporation Act, as applicable to nonprofit corporations, or other applicable law as then in effect, from paying such indemnification. The right of indemnification conferred in this paragraph shall be a contract right and shall include the right to be paid by the corporation the expenses incurred in defending any such proceeding in advance of its final disposition; provided, however, that the payment of such expenses in advance of the final disposition of a proceeding shall be made only upon delivery to the corporation of any undertaking, by or on behalf of such trustee or officer, to repay all amounts so advanced if it shall ultimately be determined that such trustee or officer is not entitled to be indemnified under this paragraph or otherwise.

B. The right to indemnification and the payment of expenses incurred in defending a proceeding in advance of its final disposition conferred in this Article shall not be exclusive of

any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Incorporation, Bylaws, agreement, vote of disinterested directors or otherwise.

C. The corporation may maintain insurance, at its expense, to protect itself and any trustee, trustee, officer, employee, or agent of the corporation or another corporation, partnership, joint venture, trust, or other enterprise against any expense, liability, or loss, whether or not the corporation would have the power to indemnify such person against such expense, liability, or loss under the Washington Business Corporation Act, as applicable to nonprofit corporations.

**FOURTH:** Each foregoing amendment was adopted by the Board of Trustees, by majority vote thereof, on October 20, 2015. There being no members of the corporation no further action was required pursuant to RCW 24.03.165(2).

**FIFTH:** These Articles will be effective on filing.
